The Company announces that to satisfy continued investor demand it has issued 1,000,000 new Euro ordinary shares of no par value (the "New Shares") at a price of €1.03 per New Share raising €1.03 million (before costs and expenses). The Placing Price represents a premium of approximately 3% to the unaudited NAV as at 31 January 2017, adjusted for the dividend declared on 20 January 2017 for the period to 31 December 2016. The New Shares will be eligible for the dividend payable in respect of the period from 1 January 2017 to 31 March 2017.

The net proceeds of the Placing will be invested in accordance with the Company's investment policy in the existing pipeline of opportunities.

Applications have been made to the Channel Islands Securities Exchange Authority Limited (the "CISEA") for the New Shares to be admitted to the Official List of the CISEA and to the London Stock Exchange for the New Shares to be admitted to trading on the Specialist Fund Segment (together, "Admission"). It is expected that Admission will become effective on 10 March 2017 and that dealings in the New Shares will commence at that time. The Board is aware that there may be further unsatisfied demand for New Shares and reserves the right to issue further ordinary shares at its sole discretion.

Following Admission, the Company will have 396,981,446 Euro shares in issue. Therefore, the total number of voting rights of the Company will be 396,981,446 and this figure may be used by shareholders as the denominator for the calculations by which they will

determine if they are required to notify their interest in or a change to their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
