In accordance with generally accepted accounting principles ("GAAP"), the Fund estimates that 81.97% of that distribution is attributable to current fiscal year net investment income and 18.03% is attributable to realized short-term capital gains.

As such, all or a portion of this distribution may be reportable as taxable income on your 2013 federal income tax return. The final tax character of any distribution declared in 2013 will be determined in January 2014 and reported to you on IRS Form 1099-DIV.
