




#### **Footnotes**

- (1) Numbers may not sum to 100.00% due to rounding. The Fund's Cash and Other represents net cash and other assets and liabilities, which includes amounts payable for investments purchased but not yet settled and amounts receivable for investments sold but not yet settled. The Fund uses funds from its leverage program to settle amounts payable for investments purchased, but such amounts are not reflected in the Fund's net cash. Therefore, the amounts payable for investments purchased but not yet settled may exceed the amount of cash on hand at period end.
- (2) Represents annualized distribution rate using December monthly dividend of \$0.082/share and market price/share as of 12/31/20. The Fund declares a set of monthly distributions each quarter in amounts closely tied to its recent average monthly net income. As a result, Blackstone Credit expects that the monthly distribution amounts for the Fund will vary quarter-to-quarter.
- (3) The Fund utilizes leverage as part of its investment strategy and currently has borrowings under a credit facility as well as mandatory redeemable preferred shares. The Fund's leverage under the credit facility without the use of mandatory redeemable preferred shares was 31.36% as of 12/31/20.
- (4) Figures exclude any equity investments in the Fund.
- (5) Loan durations are based on the actual remaining time until LIBOR is reset for each individual loan.
