

BLACKSTONE / GSO SENIOR FLOATING RATE TERM FUND

Statement Pursuant to Section 19(a)

of the Investment Company Act of 1940

On November 29, 2013, the Fund paid a distribution on its common stock of \$0.11 per share to shareholders of record at the close of business on November 18, 2013. In accordance with generally accepted accounting principles (“GAAP”), the Fund estimates that 47.98% of that distribution is attributable to current fiscal year net investment income, 43.09% is attributable to realized short-term capital gains, and the remaining portion is paid from realized long-term capital gains.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income on your 2013 federal income tax return. The final tax character of any distribution declared in 2013 will be determined in January 2014 and reported to you on IRS Form 1099-DIV.
