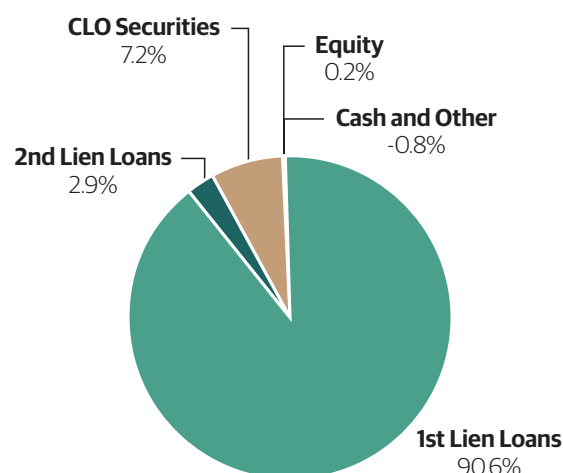

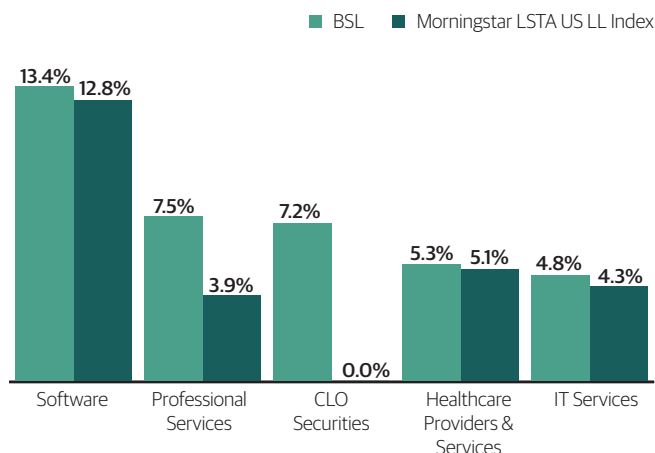

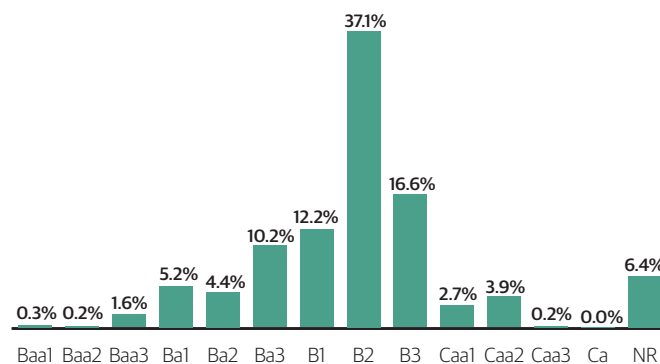

- The Fund's primary investment objective is to seek high current income, with a secondary objective to seek preservation of capital, consistent with its primary goal of high current income. Under normal market conditions, the Fund will invest at least 80% of its Managed Assets in senior loans
- The Fund is a diversified closed-end management investment company with a limited term, and, absent shareholder approval to extend the life of the Fund, the Fund will dissolve on or about May 31, 2027

As a result, BXC1 expects that the monthly distribution amounts for the Fund will vary quarter-to-quarter.
- (2) Returns for periods greater than one year are annualized. BSL NAV returns assume distributions are reinvested pursuant to the Fund's dividend reinvestment plan. Performance data quoted represents past performance and does not guarantee future results.
- (3) Numbers may not sum to 100.00% due to rounding.
