**BLACKSTONE / GSO LONG-SHORT CREDIT INCOME FUND
DECLARES MONTHLY DISTRIBUTIONS OF \$0.108 PER SHARE**

New York, New York – Blackstone / GSO Long-Short Credit Income Fund (the “Fund”) (NYSE: BGX) announced the declaration of monthly distributions of \$0.108 per common share, payable on the dates noted below. Based on the Fund’s initial public offering price of \$20.00 per share and current share price of \$19.03 (as of its close on November 29, 2012), the distributions represent an annualized yield of 6.48% and 6.81% respectively.

The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund’s investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The Fund will send to investors, a Form 1099-DIV for the calendar year that will define how to report these distributions for federal income tax purposes.
