**BLACKSTONE / GSO SENIOR FLOATING RATE TERM FUND
DECLARES MONTHLY DISTRIBUTIONS OF \$0.11 PER SHARE**

New York, New York – Blackstone / GSO Senior Floating Rate Term Fund (the “Fund”) (NYSE: BSL) announced the declaration of monthly distributions of \$0.11 per common share, payable on the dates noted below. Based on the Fund’s initial public offering price of \$20.00 per share and current share price of \$20.31 (as of its close on May 29, 2013), the distributions represent an annualized yield of 6.60% and 6.50%, respectively.

The final determination of the source of these distributions will be made after the Fund’s year end.

The amounts and sources of distributions reported are only estimates and are not provided for tax reporting purposes. The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund’s investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The Fund will send to investors, a Form 1099-DIV for the calendar year that will define how to report these distributions for federal income tax purposes.
