**BLACKSTONE / GSO SENIOR FLOATING RATE TERM FUND
DECLARES MONTHLY DISTRIBUTIONS OF \$0.10 PER SHARE**

New York, New York – Blackstone / GSO Senior Floating Rate Term Fund (the “Fund”) (NYSE: BSL) announced the declaration of monthly distributions of \$0.10 per common share, payable on the dates noted below. Based on the Fund’s current share price of \$17.61 (as of its close on September 8, 2014), the distributions represent an annualized yield of 6.81%.

A portion of each distribution may be treated as paid from sources other than net investment income, including but not limited to short-term capital gain, long-term capital gain or return of capital. The final determination of the source of these distributions will be made after the Fund’s year end.

Of the \$0.10 per share payable on October 31, 2014, \$0.039 is a short-term capital gain spillover distribution and \$0.040 is a long-term capital gain spillover distribution; both from the fiscal year ended December 31, 2013.

The amounts and sources of distributions reported are only estimates and are not provided for tax reporting purposes. The actual amounts and sources of the amounts for tax reporting purposes will depend upon the Fund’s investment experience during the remainder of its fiscal year and may be subject to changes based on tax regulations. The Fund will send to investors, a Form 1099-DIV for the calendar year that will define how to report these distributions for federal income tax purposes.

The Fund is a non-diversified, closed-end management investment company that is managed by GSO / Blackstone Debt Funds Management LLC, an affiliate of The Blackstone Group L.P. The Fund’s primary objective is to seek high current income with a secondary objective to seek preservation of capital, consistent with its primary goal of high
