

**BLACKSTONE REAL ESTATE INCOME FUND  
BLACKSTONE REAL ESTATE INCOME FUND II**

***Statement Pursuant to Section 19(a)-1  
of the Investment Company Act of 1940***

On January 17, 2019, Blackstone Real Estate Income Fund and Blackstone Real Estate Income Fund II (each a “Fund”) will pay a distribution to their respective shareholders of record at the close of business on December 31, 2018. In accordance with U.S. generally accepted accounting principles (“GAAP”), each Fund estimates that a portion of that distribution is attributable to current fiscal year net investment income, short term capital gains, long term capital gains and return of paid-in capital surplus, as indicated below:

- Blackstone Real Estate Income Fund (Common Shares of Beneficial Interest): total distribution of \$7.29, of which \$6.34 (86.97%) is estimated to be net investment income and \$0.95 (13.03%), is estimated to be long term gains.
- Blackstone Real Estate Income Fund II (Advisor Class I Common Shares of Beneficial Interest): total distribution of \$28.88, of which \$3.52 (12.19%) is estimated to be net investment income, \$9.54 (33.03%) is estimated to be short term gains and \$15.82 (54.78%) is estimated to be long term gains.
- Blackstone Real Estate Income Fund II (Institutional Class II Common Shares of Beneficial Interest): total distribution of \$29.32, of which \$3.96 (13.51%) is estimated to be net investment income, \$9.54 (32.54%) is estimated to be short term gains and \$15.82 (53.95%) is estimated to be long term gains.

The timing and character of distributions for federal income tax purposes are determined in accordance with income tax regulations which may differ from GAAP. As such, all or a portion of this distribution may be reportable as taxable income on your 2018 federal income tax return. The final tax character of any distribution declared in 2018 will be determined in January 2019 and reported to you on IRS Form 1099-DIV.
