The Board has today declared a dividend of €0.015 per ordinary share in respect of the period from 1 April 2020 to 30 June 2020.

This dividend is payable on 28 August 2020 to shareholders on the Company's share register as at the close of business on 31 July 2020, and the corresponding ex-dividend date will be 30 July 2020.

The dividend is capable of being paid in Pound Sterling, rather than Euros, provided that the relevant shareholder has registered to receive their dividend in Pound Sterling under the Company's Dividend Currency Election, or registers to do so by the close of business on 7 August 2020.
