As at 5.00pm on 30 November 2021, the Company's issued share capital consisted of 463,042,276 Ordinary Shares of no par value, each carrying the right to 1 vote and denominated in Euros.

The total number of voting rights in the Company is, therefore, 463,042,276. The Company also holds 19,860,518 Ordinary Shares in treasury.

The above figure 463,042,276 may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in or a change to their interest in the Company under the FCA's Disclosure Guidance and Transparency Rules.
